HUNTING AGREEMENT

Payment must be received before passes will be given.

Hunter will receive a vehicle pass (to be placed on dash board visible through windshield), and a wallet pass.

Realize that this land belongs to someone. It is their property, home and livelihood. Because this is a self-patrolling hunting group it is imperative that hunters follow all the rules to maintain the privilege of hunting and to be able to return to hunt. Don't ruin it for others.

RULES AND CONDITIONS

1. One pass per person, non transferable.
2. Hunter must stay on posted ground, maps are provided; watch for boundaries.
3. Use improved service roads only. Do not drive in fields.
4. Respect property. Do not dig blinds without permission of property owners.
5. No commercial hunters and no professional guides allowed on this donated ground.
6. Give landowners their privacy.
7. There are over _____ acres of land available, there is no need for everyone to be in the same place.
Do not hunt properties without consent of fellow passholders that are already there.
8. Please abide by the good sportsman's code of ethics to insure the future of this program.
9. For safety, please do not hunt in orchards, tall grass or near homes.
10. No Litter!
11. Hunt at your own risk.
12. **This pass may be revoked at any time if misused.**

SAFETY AFFIRMATION AND RELEASE

I have entered into the foregoing Hunting Agreement (the "Agreement") to hunt on posted lands managed by the Royal Youth Booster Assn. (the "Boosters") and have paid therefore the sum indicated.

I herewith confirm and certify that I am knowledgeable and fully aware, that hunting involves many elements of risk of personal injury or death and property damage to my vehicles and equipment by reason of the dangers inherent in using firearms and unknown or unobserved conditions of the lands on which I may hunt. I also understand that the Boosters do not supervise my hunting or serve as the guardians of my safety and that I will be furnishing my own firearms and equipment and will be solely responsible for the care and safety with which I hunt and use my firearms and equipment. I have been advised that the Boosters (including land owners providing the lands to the Boosters for hunting) would not have permitted me to enter into the Agreement without the execution of a release by me releasing the Boosters and landowners from liability.

In light of the foregoing and in consideration of being permitted to hunt under the terms of the Agreement, I personally assume each and every risk of injury or death to me or damage to my property as a result of my hunting activities on lands provided under the Agreement should casualty or accident occur, whether foreseen or unforeseen, and I, for myself, my family, my estate, my heirs, my assigns, and successors-in-interest release, remise, and forever discharge the Boosters and the landowners upon whose lands I hunt and their respective officers, directors, employees, agents, assigns, families, estates, heirs, and successors, or any other person working or assisting them of and from all claims, demands, actions, causes of actions, damages, and liabilities of any kind for injuries, death, or other damages to me or my property or my family, my estate, my heirs, my assigns, and my successors which may result from any cause or fault whatsoever.

I confirm and certify that my request to hunt on lands being provided by the Boosters pursuant to the Agreement and entry into the Agreement by me is completely voluntary and without duress or coercion of any kind from any source. I further affirm and certify that I am of lawful age and legally competent to sign this instrument; that I understand the terms herein are contractual and not a mere recital; and, that I have signed this instrument as my own free act.

I have fully informed myself of the contents of this instrument by reading it before I signed it and not merely scanning it. I assume as my own responsibility, my decision to hunt on lands provided by the Boosters. This instrument constitutes a voluntary expression of my knowledge and intent.
